- 5. Minutes of the January meeting

Eilidh McLeod proposed acceptance of the minutes, seconded by Kathleen Cameron.

6. Matters arising from the January meeting

Letter sent to THC re speeds at the north end of Aviemore. Holding reply received. PL confirmed that a response was submitted re the proposed telecoms mast at Glenmore.

7. Treasurer's report

Eilidh McLeod proposed acceptance of the Treasurer's Report, seconded by Roddy Stevens.

8. Police report

Neil MacIver said there had been 113 incidents in the past month. Quieter than previous months and around normal for the time of year.

9. Business

a. Scottish Youth Parliament - Presentation

The meeting heard a presentation from Hamish Nott and Jake MacCulloch on their work as members of both the Scottish and Highland Youth Parliaments. This covered the role of the MSYP, and how young people can influence the policy agenda at local and national level. Both were attending local Community Council meetings to gain experience and raise the profile of their work.

Recent issues highlighted include climate change, mental health and the impact of vaping.

Subsequent discussion covered the impact and consequences of selling vapes to those underage, and how best to include young people in future Community Council discussions.

The meeting was pleased to note that the Highland mental health poster competition was won by an entrant from Carr-Bridge.

Eilidh McLeod thanked Jake and Hamish for their presentation and wished them well in their future work. Hamish Nott left the meeting at this point.

b. The Highland Council - Review of Community Councils

The meeting considered the proposed amendments to the Scheme of Establishment for Community Councils. Most changes were welcomed or felt to be acceptable.

The letter from Nairn River CC regarding proposed local boundary changes was noted.

Peter Long proposed that AVCC respond with a) CCs still require practical support with emails/websites and IT generally, and b) that CCs should only be merged where one CC is inactive, or where both CCs consent. Seconded by Jeni Pacitti.

c. Local Development Plan, Draft Delivery Programme - CNPA

It was noted that the document largely brings together information already available elsewhere.
